In reference to the letter from the Minister of Sport and Tourism dated 30 July, 2018, the Polish Archery Federation informs that at the meeting of the Board of the Polish Archery Federation on 10 August, 2018 in Kielce, the Board of the Polish Archery Federation (hereinafter referred to as PAF) has adopted the following resolutions:

1. Resolution No. 3/8/2018 of the Board of the Polish Archery Federation of August 10, 2018 The Board of the Polish Archery Federation repeals the resolution of the Polish Archery Federation's Board. No. 2016/5/7 dated 29.07.2016 with the wording "The Board of Polish Archery Federation adopts dates, locations and PAF's Agents to the provincial conventions that will elect delegates to the General Reporting and Election Assembly, delegates in accordance with the attached list and statute."
2. Resolution No. 4/8/2018 of the Board of the Polish Archery Federation of August 10, 2018 The Board of the Polish Archery Association sets the date on 17/11/2018 and place: Bytom, conference room of the Tańca Theater and Ruch "Rozbark" ul. Kilar 29 convocation of the Extraordinary General Assembly of Delegates of the Polish Archery Federation in order to conduct the elections: the President, the PAF's Board and the Audit Commission of the PAF.
3. Resolution No. 5/8/2018 of the Board of the Polish Archery Federation of August 10, 2018 The Board of the Polish Archery Federation has passed a resolution to carry out the regional conventions by the Regional Archery Federations in order to elect delegates for the Extraordinary General Assembly of Delegates of the Polish Archery Federation on 17/11/2018 The deadline for organize the provincial conventions is set by October 10, 2018.
